- 1. The meeting was called to order at 5:00 PM.
- 2. The board heard a presentation about the IVN Japanese Program at the local school districts.
- 3. The board held the first reading of board policy 3231 Outside Activities of Staff.
- 4. The board approved medical leave requests for two ISD employees.
- 5. The board approved the establishment and posting of an Early Childhood Speech and Language Pathologist position, effective immediately.
- 6. The board approved the establishment and posting of 1 GSRP teacher, 1 GSRP teacher assistant and 4 program support aide floater positions at Custer Elementary.
- 7. The board approved the establishment and posting of two school nurse positions, effective immediately.
- 8. The board approved an increase in workdays for Early Home Visiting and Parent Educator positions between October 1, 2021 and September 30, 2022.
- 9. The board approved Kathy Lambrix as a temporary local based special education teacher at Bedford High School for two days a week from September 20, 2021 through December, 2021, or until the position is filled.
- 10. The board approved an increase in workdays for Kristin Miller, Early On Parent Educator, from 192 days to 240 days effective October 1, 2021.
- 11. The board approved an increase in hours per week and single insurance benefits for the open Early On Parent Educator position from 192 days to 240 days and 35 hours per week, effective October 1, 2021 under the Early On 54D grant.
- 12. The board approved a 1.5% rate increase for Michelle Haas-Nelson, Youth Center Liaison.
